Subject: Indian Industries Association (IIA) CEC Election Notice 2017-18.

Dear Members,

The process of CEC Election for the year 2017-18 of Indian Industries Association for 8 (Eight) vacant posts from the chapters/areas has started. The tenure of these seven elected CEC Members will be for 3 (three) years and for one Elected CEC Member will be for one year as per the details given below:

As such, the nominations for CEC Elections are invited from IIA members from these areas/chapters only.

For nomination in the CEC elections of IIA, only those members will be allowed to participate who satisfy the following eligibility criteria:

- 1) Eligible Members shall be that who's Chapter Contribution has been received by IIA Head Office till 31st March, 2017. Any member who has not paid his subscription in full for the year 2016-17 shall not be entitled to vote.
- 2) The candidate must have minimum 5 years of continuous membership of IIA.
- 3) The candidate must possess a valid MSME Entrepreneur Memorandum Part-II acknowledgement/ Udyog Aadhar. **(Copy of the acknowledgement/ Udyog Adhaar must be enclosed along with the nomination form).**
- 4) The candidate must have been an office bearer at Chapter level having an exposure of CEC meetings at Central level/Divisional level /Working group head at Central level.

- 5) The candidate must have complete faith on IIA Constitution, Culture and values and must not have indulged in any kind of anti IIA activities at any point of time.
- 6) Employee other than Director in a Pvt. Ltd Company of a member enterprise will not be eligible for the election as CEC member of IIA.

Other applicable rules and regulations:

- a) Elected CEC member can be elected for maximum two terms. However elected CEC Member will not be eligible for election for the consecutive term.
- b) Elected CEC Member will lose his / her status as CEC Member for remaining tenure (subject to the approval of President) in case his / her attendance in CEC Meeting in a year is less than 50%. For such remaining tenure, CEC may nominate / elect another senior member from the respective area and the criteria of minimum attendance will apply to such nominated member also.

The Nomination form for 8 (Eight) vacancies is enclosed along with this notice. The members may fill the nomination form and send it to IIA Head Office on or before the last date of the receipt of filled nomination forms, i.e. 25.04.2017. Any nomination received after the prescribed date will be summarily rejected. IIA Election notice has been uploaded on IIA website www.iaaonline.in and is also sent to IIA Chapter's Chairpersons for informing every eligible member in respective chapter. Election Notice will also be published in IIA News of March, 2017 edition as well as will be sent through email to all IIA members. IIA members will be informed through SMS also about the election process.
