Subject: Problem of power cut to industries in UP.

IIA Chapters from all over the State have informed that there is a scheduled power cut from 11:00 AM to 8:00 PM as well as from 10:00 PM to 3:00 AM every day apart from un scheduled interruptions. Due to this power rostering, industries in U.P. are not able to function properly even for a single shift.

During the scheduled power cut in the night even street lights in the industrial areas are switched off resulting in a serious security threat to the industries.

In view of the above situation we, request you as following:-

1. If unavoidable the scheduled power rostering to industries may be resorted to during the night only and the scheduled day rostering should not be done so that industries will be able to carry out their production for atleast one/two shifts.
2. Street lighting in Industrial areas may be kept on during the night through single phase supply.

We hope you will be kind enough to accept our request in the overall interest of the Industrial Production of the state as well as government tax revenue.

A delegation of IIA would like to meet you urgently on this issue at any time convenient to you.

उत्तर प्रदेश में विद्युत कटौती से औद्योगिक उत्पादन शून्य, समस्या के समाधान हेतु आई0आई0ए0 ने अध्यक्ष एवं प्रबन्ध निदेशक UPPCL को प्रदेश में उद्योगों को की जा रही विद्युत कटौती तत्काल समाप्त करने के लिए प्रत्यावेदन दिया। प्रेस विज्ञप्ति आपके प्रतिष्ठित समाचार पत्र में प्रकाशित करने हेतु प्रेषित है :-

विद्युत कटौती से प्रदेश में औद्योगिक उत्पादन शून्य

नई उ0प्र0 सरकार ने यह वादा किया था कि प्रदेश में उद्योगों को निर्बाध विद्युत आपूर्ति की जायेगी इससे प्रदेश के उद्यमियों को नई उम्मीद की किरण नजर आई थी। परन्तु आज की स्थिति यह कि उद्योगों को अप्रत्याशित विद्युत कटौती का सामना करना पड़ रहा है। स्थिति यह है कि प्रदेश के उद्योगों को दिन में 11 से 8 बजे तक तथा रात 10 बजे से 3 बजे तक बिजली नहीं मिल पा रही है। कुल मिलाकर उद्योग एक शिफ्ट भी उत्पादन नहीं कर पा रहे हैं परिणामस्वरूप उद्योगों का चक्का जाम हो चुका है।

अध्यक्ष आई0आई0ए0 ने अध्यक्ष एवं प्रबन्ध निदेशक UPPCL से निवेदन किया है कि उद्योगों को विद्युत कटौती कम से कम दिन के समय न की जाय एवं औद्योगिक क्षेत्रों में सुरक्षा के मद्देनजर स्ट्रीट लाइट चालू रखी जाए।

आई0आई0ए0 ने अध्यक्ष एवं प्रबन्ध निदेशक UPPCL से मिलने का समय मांगा था परन्तु आई0आई0ए0 को समय नहीं मिल पाया है।

महासचिव आई0आई0ए0 ने बताया कि यदि कल तक स्थिति नहीं सुधरी तो उद्योग प्रदेश भर में धरना प्रदर्शन प्रारम्भ कर देंगे।

We are forwarding you a press note **“Industrial production stopped due to power cut in UP”** with the request that it may be published in your esteemed newspaper:-

Industrial production stopped due to power cut in UP

New Govt. in UP promised that they will provide uninterrupted power supply to the industries of the state. This announcement of the govt. showed a new ray of hope to the industrialists of the state. But the situation today is that the industries of the state are facing unprecedented power cut. Industries are not getting electricity from 11 AM to 8 PM and 10 PM to 3 AM. Because of this power cut industries are not able to work even for a single shift. As a result of this the whole industrial production in the state has stopped.

President IIA requested Chairman and Managing Director UPPCL that the power cut to industries may not be done atleast during day time and the street lights should be kept on to ensure security and safety in industrial areas.

IIA requested Chairman and Managing Director UPPCL to provide time for a meeting with IIA delegation to work out a plan to resolve this problem but IIA have not got any response as yet.

General Secretary, IIA said that if the situation will not get mended till tomorrow the industrialist will start agitation all over the state.
