Subject: CEC Election Notice for filling one Vacant Seat of Central Executive Committee Member.

Dear Members,

This is reference to the Indian Industries Association (IIA) CEC Election Notice 2025-26 vide ref. No. 1/Election/1221 dated 10th May 2025 and subsequent decision of the 5 Members Committee dated 21st May 2025 to merge IIA Head Office + Uttrakhand Constituency with Ayodhya and Lucknow Division (except Lucknow Chapter). As per the decision of the 5 Members Committee, one CEC Member of IIA was to be elected from IIA Members of Unnao, Raebareli Sitapur & Hardoi Chapters and in other States except Haryana, Gujrat, Delhi & remaining Chapters in U.P.

For this vacancy, one nomination received from Unnao Chapter was found invalid on scrutiny on 26th May 2025. Hence the seat remained vacant.

The matter of this one vacant seat of IIA CEC was placed before the Central Executive Committee on 6th June 2025 in its meeting held at IIA Bhawan, Vibhuti Gomti Nagar, Lucknow where in it is decided that re-election for filling up this seat from Lucknow Division (Except Lucknow Chapter) & other states except Haryana, Gujrat, Delhi and remaining Chapters in U.P will be conducted by the IIA Election Officer 2025.
