# C) Periodicity & Eligibility:

The MSMEs should have been in continuous manufacturing / services for last 04 years (2013-14, 2014-15, 2015-16 and 2016-17). The Awards will be given to deserving Micro, Small and Medium Enterprises which have Udyog Aadhaar Memorandum (UAM). MSMEs would also register in MSME Data Bank, Web Portal: <a href="http://www.msmedatabank.in">www.msmedatabank.in</a> (click on register in MSME Data Bank, Web Sources and the MSME) before submission of their application. Registration at MSME Data Bank is mandatory for MSMEs even if they have earlier obtained UAM.

The awardee shall not be nominated or considered for the same or lower category of award in the subsequent 05 year(s). However, there will be no bar for an awardee to be nominated or considered for a higher category of award in subsequent year.

- D) Privilege: The winners of the awards shall have the privilege of allowing their employees to wear labels, pins, ties, I ogo or other distinctive badges with the symbol of the awards indicating the year of award inscribed on it. The entrepreneurs can also use the symbol on their letter -heads or any advertisement issued alongwith the year of the award. The amount of cash priz e received by the winners is exempted under Section 10(17) of Income Tax Act 1961.
- E) How to apply: The eligible enterprises and States/UTs will submit online (hyperlink – msmedi.dcmsme.gov.in/award.aspx) applications comprising of Part-I and Part-II of relevant category of awards. An enterprise can apply for more than one category of award. The last date for submission of application is 15.10.2017.
